

All you need to know about Diesel Driving Bans in Germany!









Two Blue Badges?

The German Federal Environmental Agency is planning to introduce two new badges in order to identify vehicles with low NOx emissions. A badge alone is not enough, because even the newest diesel engines have been manipulated in terms of pollutant levels and exceed the permitted NOx emissions. For this reason, two blue badges could soon be introduced: a light blue one for retrofitted EURO 5 diesel and already approved EURO 6 diesel, a dark blue one for the latest EURO 6 and 6-Temp diesel. However, the dark blue badge is only required in small and heavily polluted areas. This would also facilitate the gradual introduction of driving bans as stipulated by the Court in Stuttgart.

Petrol vehicles with EURO 3-6 standards without direct injection.



Petrol vehicles with EURO 6c and 6d-TEMP standards and direct injection.



Petrol vehicles with EURO 3-6 standards, direct injection and particulate filter.



Diesel vehicles, diesel trucks/commercial vehicles with EURO 6d-TEMP standard.



CNG/LPG –vehicles as cars, trucks, buses with EURO 3 to 6d-TEMP standards.



Electric vehicles without combustion engine.

Attention: Since there are no legal requirements in Germany, which vehicles should receive a Blue Badge, the abovementioned proposals and ideas of the German Association for the Environment (DUH), the Federal Environmental Agency and other institutions are not yet legally binding.
